## California Distinguished Schools

- ACS received an e-mail on 2/8 stating that we are eligible to apply for California Distinguished School Award.
- We need to apply by 3/12/18 in order to be recognized as a California DS Awardee in 2018

### The California Program Information

Distinguished Schools (DS) Program was on a three year pause while California transitioned to its new assessment and accountability system. From 2015–17 California recognized schools that demonstrated exemplary achievements with the California Gold Ribbon Schools Program. The California DS Program recognizes elementary and middle and high schools in alternate years and allows eligible schools to apply for the California DS Award once every two years. In 2018 California will recognize outstanding education programs and practices in elementary schools. Schools recognized as a California DS Awardee hold the DS Title for two years.

### Eligibility Criteria

In 2018 California is using a multiple measures accountability system to identify eligible schools based on their performance and progress on the state indicators as specified on the California School Dashboard (Dashboard). Information regarding the Dashboard is provided on the California Department of Education (CDE) California Accountability Model and School Dashboard Web page. Kindergarten thru eighth grade (K–8) grade span designation is accepted. Eligible schools will be selected within the following three categories:

### **Update on School Testing (Interim Assessment Blocks)**

Optional interim assessments allow teachers to check student progress throughout the year, giving them information they can use to improve their instruction and help students meet the challenge of college- and career-ready standards. These tools are used at the discretion of schools and districts, and teachers can use them to check students' progress at mastering specific concepts at strategic points during the school year. Interim assessments consist of the following features: (IABs) that focus on smaller sets of related concepts and provide more detailed information for instructional purposes.

### **ELPAC (English Language Proficiency Assessment of California)**

Students in kindergarten through grade twelve, who are classified as English learners, will take the ELPAC Summative Assessment every year until they are reclassified as proficient in English. Students are tested on their skills in listening, speaking, reading, and writing.

### **Update on Prop 39**

- Received 18-19 preliminary proposal for both Erwin and Slymar campus from Prop 39 for on February 1, 2018

**Update on Wilkinson's Audit Findings for Unduplicated Counts**

**Unduplicated Counts:**

**How are “unduplicated pupils” defined for purposes of calculating supplemental and concentration grant amounts?**

Supplemental and concentration grant amounts are calculated based on the percentage of “unduplicated pupils” enrolled in the LEA on Census Day (first Wednesday in October) as certified for Fall 1. The percentage equals:

- Unduplicated count of pupils who (1) are English learners, (2) meet income or categorical eligibility requirements for free or reduced-price meals under the National School Lunch Program, or (3) are foster youth. “Unduplicated count” means that each pupil is counted only once even if the pupil meets more than one of these criteria (EC sections 2574(b)(2) and 42238.02(b)(1))
