The Ararat Charter School ("School") welcomes your participation at the School's Board meetings. 1. Update on English Learner Instruction and Assessments

• LAUSD EL Reclassification Benchmark

The school shall provide a written status report to the Charter Schools Division (CSD) no later than December 1 of each year of the charter term demonstrating its progress related to the following:

Ararat Charter will demonstrate an ongoing increase in reclassification of its English
Learners to meet or exceed the Resident Schools Median reclassification rate over the course
of the five-year term of their renewal.

Ararat Charter's 2020-2021 Reclassification Rate is 8.0% which is 5.7 percentage points higher than the Resident Schools Median of 2.3%. As such, Ararat Charter has exceeded the Resident Schools Median reclassification rate and has met the benchmark for the 2020-2021 school year.
