To assist you in the ease of speaking/participating in our meetings, the following guidelines are provided.

- 1. Agendas are available to all audience members at the door to the meeting.
- 2. "Request to Speak" forms are available to all audience members who wish to speak on any agenda or non-agenda items or under the general category of "Oral Communications."
- 3. "Oral Communications" is set aside for members of the audience to raise issues that are not specifically on the agenda. However, due to public meeting laws, the Board can only listen to your issue, not respond or take action. These presentations are limited to three (3) minutes and total time allotted to non-agenda items will not exceed fifteen (15) minutes. The Board may give direction to staff to respond to your concern or you may be offered the option of returning with a citizen-requested item.
- 4. With regard to items that are on the agenda, you may specify that agenda item on your blue request form and you will be given an opportunity to speak for up to three (3) minutes when the Board discusses that item.
- 5. When addressing the Board, speakers are requested to state their name and address from the podium and adhere to the time limits set forth.
- 6. Citizens may request that a topic related to school business be placed on a future agenda. Once such an item is properly agendized and publicly noticed, the Board can respond, interact, and act upon the item.

#### Update on Wilkinson's Audit

- ACS had its annual audit scheduled for 7/24/18
- All requested audit document was electronically sent to auditors
- Wilkinson determined that it was not necessary to visit in person as all documents had been submitted electronically
- ACS needs to submit revised P-Annual report to Wilkinson's once it is submitted to LAUSD
- The auditors did not foresee any findings for the audit they conducted. We will have a finalized report once the revised P-Annual report is submitted to Wilkinson's

#### **Update on Prop 39**

- ACS received furniture and projector for new teaching station at campus 2. ACS is waiting to receive laptops that
  will be provided by Prop 39. The new room provided has been designated as a SPED room in the District's final
  proposal
- ACS has been offered one extra teaching station for 18-19 school year. Teaching station may be utilized for computer lab and Choir and other instruction for students.
- Our response to the Districts final offer has been submitted to Prop 39.
- The District did not respond to our specific concerns about the Library and Parent Center. ACS will be able to address these concerns when our shared used agreement is completed with Erwin's administration

#### C. FINANCIAL REPORT

This is an update from what has transpired since the last board meeting.

- 1. **Budget to date:** Mr. Levi Kirkland from Edtec reported on the Unaudited Actual Report which is due to LAUSD on August 20<sup>th</sup>. Mr. Kirkland also reported on the Monthly Financial Update Report. The following items were discussed:

Year-End Net Income is \$170k higher than the May Forecast Budget

Ararat ended FY 17-18 with a cash balance of \$3.1M

#### **LCFF**

- Includes \$3B increase to *fully fund LCFF*, two years ahead of schedule
- 100% gap closure and 3.7% increase of base rates

#### **COLA**

- 3.7% COLA increase, versus previous 2.51%
- Affects programs such as Special Education and Nutrition

#### One-Time Funds

• Includes over \$1.1B in one-time, discretionary funding (~\$180 / PY ADA), down about \$163 from the May

#### Revise

• \$300M in One-Time funding being allocated to Low Performing Students

#### **Facilities**

- Proposes increasing 18-19 program funding to \$136.8M (down \$3.6M from January)
- Increases funding in 2017-18 funding to \$133.2M
- Decreases deficit factor from 25% to 10%
